
# **Good practice: transparency requirements**

"In March 2013, a web portal and public procurement electronic database was launched by a local NGO as a result of an EU-funded project. The database consolidates information on the implementation of public procurement procedures and companies involved and is available to the public free of charge. It also contains information on the assets and interests of public officials, in line with asset disclosure rules. Such aggregated data allow the carrying out of cross-checks."
