## **Figures**

- Transparency International CPI from 2.5 in 2005 in 3.4 in 2008
- 11 out of 13 GRECO recommendations fulfilled
  2004 2007
- IDRA/USAID Survey victimization from corruption decreased from 1.7 in 2005 to 1.29

## Instruments

#### New strategic approach

 Crosscutting Strategy on Prevention, Fight against Corruption and Transparency in Governance 2008 – 2013 (October 2008).

#### Political level of responsibility

 Anticorruption Task Force chaired by the Prime Minister

#### Institutional commitment

Department of Internal Administrative Control and Anti-Corruption

## **Instruments**

#### **Effective partnerships**

 Joint Investigation Unit against Corruption and Economic Crime established in 2007 with the MoU signed between the Prosecutor General Office, Ministry of Interior, Ministry of Finance and the Intelligence Service.

#### **Monitoring commitments**

 IWG – Inter-ministerial working group (political + technical level) + participation of independent bodies and civil society

## Preventive measures

#### **Approximation of legislation**

- 1. CoE Criminal Convention against Corruption (Criminal Code and Criminal Procedure)
- 2. CoE Civil Convention against Corruption (Labor and Civil Code, commercial law, etc)
- 3. Ratification of UN Convention against Corruption
- 4. New election Code
- 5. Conflict of Interest law
- 6. Law on the participation of public in the fight against corruption

### Preventive measures

- Reduction of contacts between officials and citizens (e-procurement, on-line taxes)
- Reduction of public services costs (1 euro NA services)
- Reduction of procedures and bureaucracy (licenses and permits, one-stop shop)
- Unification of procedures (university admission exams system and state Matura)
- Conflict of Interest prevention (regulation of participation in public boards)

## Effective public funds management

Reduction of operative expenses

from 3 to 2.1 % of GDP

ALBANIA

- Fair management of procurement procedures
  - decrease of value of bids
- Increase incomes by better customs and tax administration

## Strengthening of Control and Investigation

- Department of Internal Administrative Control and Anti-Corruption
