1. SUMMARY OF REPORTS FROM THE PREVIOUS STEERING GROUP MEETING

At sessions of BH Parliamentary Assembly, held on May 4, 2004, the Law on Prevention of Money Laundering was passed. The Law stipulates measures and responsibilities for revealing, preventing and investigating money laundering and funding terrorist activities, and measures for international cooperation in the said area.

This Law enters into force six months after its publication in the Official Gazette BiH ("Official Gazette of BiH" issue 29 of June 28, 2004), on which date the following legislation will cease to be in force: Law on Prevention of Money Laundering of F BiH ("Official Gazette of F BiH" issue 8/00), Law on Prevention of Money Laundering of RS ("Official Gazette of RS" issue 52/01), and Law on Prevention of Money Laundering of Brčko District ("Official Gazette of Brčko District" issue 14/03).

2. PROGRESS MADE FROM THE LAST STEERING GROUP MEETING IN ACHIEVING THE SPAI OBJECTIVES

Adoption and implementation of European and other international instruments.

- UN MERIDA Convention against corruption has been signed on the September 16, 2005.
- European convention of mutual legal assistance in criminal matter. Ratified 22, March, 2005.
- European Convention of extradition, Ratified, 22 March, 2005.
- In May Ministry of Justice has Signed ministerial Declaration on 10 joint measures to curb corruption in SEE.
- Declaration signed on Brdo kranj Slovenia on 28 October, 2005 on the joint fight against organized crime, corruption and illegal immigration.

Promotion of good governance and reliable public administrations

• The issue of access to information is treated in Freedom of Information Acts ("Official Gazette of BiH" issue 28/00; "Official Gazette of F BiH" issue 32/01; "Official Gazette of RS" issue 20/01), which are completely harmonized.



ANTICORRUPTION INTIATIVE REGIONAL SECRETARIAT LIAISON OFFICE

- In Brčko District, the Freedom of Information Act of BiH is applied directly based on the Instruction for implementation of Freedom of Information Act of BiH in Brčko District ("Official Gazette of Brčko District" issue 36/04).
- Law on Administrative Disputes, which entered into force on February 24, 2005, administrative disputes in first instance are decided by cantonal courts having jurisdiction over the seat of first instance administrative body that made the decision.
- Rulebook on disciplinary liability of civil servants in BH institutions ("Official Gazette of BH" issue 20/03) regulates the issues of disciplinary liability, disciplinary measures, disciplinary procedures, and the execution of disciplinary measures for civil servants in BH institutions.
- Disciplinary procedure against a civil servant upon request of institutions is conducted by a disciplinary commission appointed by director of the Civil Service Agency. In two years of operation, these commissions conducted eight disciplinary procedures and corruption has not been established in any of the cases.
- Law on the Conflict of Interest in BH Institutions ("Official Gazette" issues 16/02,14/03, and 12/04).
- Law on Administration ("Official Gazette of BiH" issue 32/02)

Strengthening of legislation and promotion of the rule of law

- According to the Law on Civil Service in BH Institutions ("Official Gazette BiH" issues 12/02, 19/02, 35/03, 4/04, 17/04, 26/04 and 37/04), civil servants are recruited for BH institutions only by way of public competition, consisting of a public examination, conducted by the Agency, and professional examination, conducted by the Selection Committee. The Agency declares the most successful candidate from the list of successful candidates, whereas the institution appoints leading civil servants from the list of successful candidates.
- Law on High Judicial and Prosecutorial Council of Bosnia and Herzegovina (passed on June 1, 2004) Chapter VI stipulates disciplinary liability of judges and prosecutors. Articles 54 87 of the Law stipulate in detail the procedure, disciplinary violations of judges and prosecutors, types of disciplinary measures, appointment and term of office of disciplinary commission's members, rights of parties during disciplinary procedure, sanctions for disciplinary violations of judges and prosecutors, which range from mandatory temporary removal from office to suspension of payment of salaries and other benefits, and cessation of official duty.





Promotion of transparency and integrity in business operations.

- In 2001, the Council of Ministers of BiH, together with he entity governments, adopted a long-term *Action Plan for the Enhancement of the Business environment to Attract Domestic and Foreign Investment*, which is now in the implementation phase.
