Background

The Stability Pact Anti-Corruption Initiative (SPAI) was launched in Sarajevo on 16 February 2000 as a regional framework for the countries of South Eastern Europe to take effective measures to fight all types of corruption at all levels, in line with international standards. The Initiative has become a comprehensive framework for capacity building of the regional countries through ongoing policy dialogue and sharing of expertise, best practices and lessons learned in the anti-corruption field.

The previous Steering Group Meeting marked the beginning of the transition of the Initiative to regional ownership. A visible benchmark of this process was the official opening of the Regional Secretariat Liaison Office (RSLO) that took place during the Regional Meeting of the Ministers of Justice under the South-East European Cooperation Process, on 27-28 October 2003.

Objectives

The main objectives of the 7th Steering Group were:

- assessment of the progress made both at national and regional level in the implementation of the SPAI Strategy adopted in September 2003;
- debating and approving the SPAI RSLO DRAFT WORK PLAN for 2004;
- identifying the short and medium term priorities for the SPAI member states and areas of assistance;
- debating and adopting a decision on the role of the SPAI in SEECP Joint Campaign to Fight Organized Crime and Corruption.

Outcomes

The meeting participants had to agree on the next steps in implementing the SPAI STRATEGY and SPAI RSLO WORK PLAN.

Participants

- Senior Representatives from all SPAI countries
- Representatives from SPAI supporting countries and international organizations.

Logistics

The Steering Group Meeting took place in Sveti Stefan, Republic of Montenegro.

Participants were accommodated in Grand Hotel Sveti Stefan or Hotel Kraljicina Plaza, both located on the coast of Montenegro, near Budva.

The Montenegrin Government in cooperation with SPAI RSLO covered the cost related to the accommodation for the SPAI countries representatives.

International travel costs and arrangements were covered by the participants. The local transportation from and to the airport was provided by the organizers.

The Steering Group Meeting was held in the Conference Room of GRAND HOTEL SVETI STEFAN.

The working language of the meeting was English.

On request organizers provided facilities for PowerPoint presentations.
